If, in the opinion of the inspector, the property contains serious 'structural, mechanical and/or other' major detects which the SELLER is not willing to repair/replace and/or make a reasonable allowance toward the purchase price satisfactory to the BUYER then this Agreement shall become null and void and the deposit returned to the BUYER.
